



## DECLARATION FOR PET TRANSPORTATION IN CABIN OR AIRCRAFT HOLD

Dear Customer,

The transportation service offered by Aerovías del Continente Americano S.A. AVIANCA and all other airlines operating under AVIANCA brand, for pets whether in cabin, or in aircraft hold, as emotional Support dogs or as Service dogs (which will be identified as PET in this declaration) is subject to the following conditions:

1. THE PET must behave appropriately in public environments, including the interior of the aircraft, and it is a unique responsibility of the passenger in charge of THE PET, to take the necessary measures for this purpose.
2. THE PET that displays any of the below signs:
  - a. Aggressive signs or behaviors
  - b. Poses a risk to the flight security,
  - c. Generate adverse effects to the health conditions of the facilities or the aircraft,
  - d. Causes inconveniences to other passengers, crew members or airline ground staff,
  - e. It is evident that the passenger in charge of THE PET cannot maintain control of it,

May not be transported in the passenger cabin. Where possible, it will be transported in the aircraft hold and the costs derived from this change will be entirely assumed by the passenger in charge of THE PET.

3. Prior to the flight, AVIANCA's staff will review, the fulfillment of all the conditions for the transport of THE PET in either, the cabin or in the aircraft hold, in accordance with the applicable regulations and/or airline policies. Please note that sanitary and phytosanitary authorities, as well as AVIANCA, may order the inadmissibility of the transport of THE PET, if they consider that it does not meet the regulatory and safety conditions suitable for travel.
4. THE PET that is under than 4 months of age will not be transported.
5. The passenger in charge of THE PET declares full knowledge and undertakes to comply with the regulations for the transport of animals, the entry and/or exit of animals of the country of origin, transiting country (if applicable) and the destination country.
6. Certain breeds of dogs and cats have a special condition called Brachycephalic Syndrome. This can increase the risk of suffocation and breathing problems to THE PET when exposed to stress, pressure or heat. For this reason, Avianca do not authorize transportation of these breeds, or those that are a cross between them, unless the passenger in charge of THE PET, who declares himself responsible of the aforementioned risks. Please find below the list of breeds:

Therefore, I declare full knowledge and certify the compliance of all the conditions required for the transportation of THE PET. I also declare that I am financially responsible for any personal or material damage that THE PET causes to AVIANCA, its collaborators and/or other passengers.

I understand and accept that THE PET may suffer respiratory trouble during the flight due to the condition of Brachiocephalic Syndrome and may be susceptible to have a heat stroke and respiratory disorder.

Taking into account the health conditions, those inherent to the nature and state of THE PET, as well as the above listed in this document pertinent to the transportation of all types of breeds, , I hereby fully and unconditionally release, relieve and exonerate AVIANCA and /or its associated and affiliated companies, its agents, officers, employees and other interested parties, from any liability, regardless of its nature, its origin and form, derived from any action or omission on my part, as the only responsible for the compliance of the Terms and Conditions established by the airline and by the applicable regulations for the transportation of my PET, as well as direct or indirect damages caused by the death, illness or injury of my PET, or by acts of local authorities decisions related to the entry, exit or transit of the same.
